Emissions Reduction Targets

In order to continue our progress to achieving Net Zero, we have adopted the following near-term and long-term science-based carbon reduction targets.

Near-Term

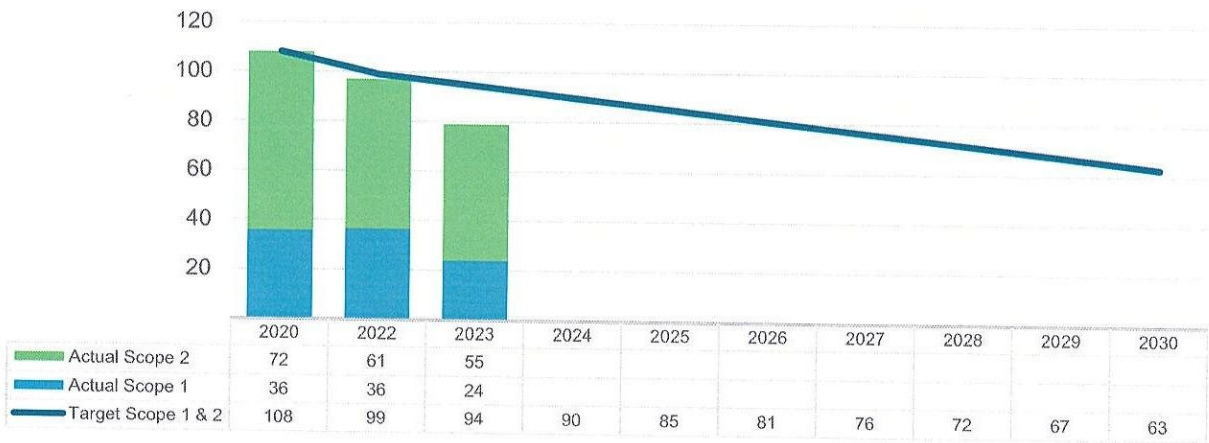
Near-term science-based targets cover an SME organisation's Scope 1 and 2 emissions reduction targets to be achieved by 2030. For Eumar Technology & Ubersorb Ltd, with base year (2020) scope 1 and 2 emissions of 108 tCO₂e, a reduction of 42% minimum will be required by 2030. This means scope 1 & 2 emissions shall be no higher than 63 tCO₂e by 2030.

Long-Term

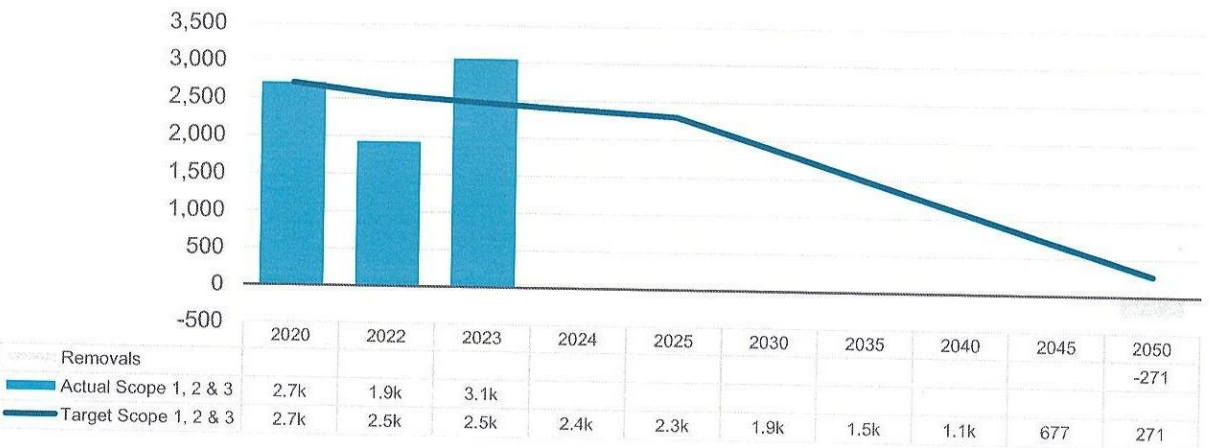
Long-term science-based targets show how much an organisation needs to reduce its total emissions (Scope 1, 2 & 3) in order to reach net-zero. This is a minimum of a 90% reduction and needs to be achieved no later than 2050. Eumar Technology & Ubersorb Ltd's total emissions in its 2020 base year were 2,707 tCO₂e. By 2050, its total emissions shall be no higher than 271 tCO₂e, with the remaining emissions being permanently balanced through nature-based or technological solutions.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the Base Year.

- Started reviewing and planning switch over to 100% certified renewable energy suppliers.
- Implemented more flexible working conditions to reduce employee commuting such as working from home, cycle to work scheme and TOIL.
- Gained ISO14001:2015 Certification & ISO14064 Certification at the end of 2023/beginning of 2024

In the future we hope to implement further measures such as:

We intend to invest in the following initiatives within the next 2 years:

- Switch to 100% certified renewable energy
- Maintain ISO14001:2015 Certification & ISO14064 Certification

These initiatives are expected to reduce our emissions by at least 45.3 tCO₂e, equivalent to a 67% reduction of our total Base Year Scope 1 and 2 emissions, in line with the Science Based Targets initiative's near-term goals.
